Hello to all our foster and kinship carers and welcome to FKAT's first newsletter for 2019. These first three months seem to be flying by, it only seems a couple of weeks ago we were sending the children off to school, and here we are approaching the middle of March with the end of first term of school and Easter on the horizon.

During February, carers were invited to attend a forum that was held around the state called "Strong Families Safe Kids". The Department of Communities has organised a multi-stakeholder process to re-imagine how government, community and NGOs work together to assist vulnerable children in Tasmania to reach their potential. It's about how families can get help earlier so they can provide a safe environment for children. It is an exciting opportunity to get the 'whole system' in the room.

There was recently a joint promotion with Children and Youth Services in the South of the state on Sunday February 10th at Village Cinemas in Hobart. It was a joint foster and kinship carer recruitment event with the Department, Key Assets, Kennerley, Fostering Hope, and FKAT. The film "Instant Family" was shown, and each organisation set up information tables to give people attending the opportunity to ask questions regards fostering.

The FKAT board recognises that some carers are not receiving information that is forwarded to all carers. The board is working hard to ensure all carers get relevant information. We acknowledge that there are carers who don't have computers or internet access, and we would like to hear from you. If you know any carers who do not have internet access, please ask them to call Kerrie Taylor (our admin assistant) at our Hobart office on 62120513. Kerrie is currently working on updating our member list, which has been no easy task. During the past year we have had an increase in membership so this will help to make sure you are on the mailing list and we have your correct address.

Last year, concerns were raised by carers regarding the after-hours emergency number and the lack of support when making contact with a duty officer. This concern was raised with the Minister's office. With upcoming changes to the after-hours emergency number, carers will receive a better response when calling the after-hours number.

The CEO will be engaging with the Department to clarify the policy regard restraining children during behavioural outbursts in the home. We hope to develop better training around the safety and risk factors to carers and children/young people in foster homes.

FKAT Regional representatives are npw meeting monthly by phone, and also having quarterly face-to-face meetings. If you have issues you want raised at these meetings please contact your regional reps and your issues will be added to the agenda.

The 'BIG DAY OUT' is to be held at YMCA Launceston this year, on May the 4th, The theme will be Star Wars. All are welcome and more information will be sent to carers over the next couple of months. Please ensure you register for this great event.

Foster

When I look up the the meaning of the word 'foster' its states 'to encourage the development of (something, especially something desirable). Synonyms for 'foster' include: encourage, promote, further, stimulate, advance, forward, cultivate, nurture, strengthen, enrich, help, aid, assist, contribute to, support, champion, speak for." These words help us understand the important role of foster and kinship carers. For a child or young person, entering the foster care system is often a frightening and stressful experience. Being taken away from the place they once felt safe and being surrounded by strangers in unfamiliar territory, is a difficult process. Foster carers provide a safe, loving environment for these vulnerable children and young persons. With their love and support, the children in their care learn to adapt and thrive.

What's Going On

We have run three FASD information workshops around the state earlier this year, and there are two FASD Master Classes coming up in Hobart and Launceston. We also held a combined event at Inflatable World with CREATE (February 23rd), with over 200 people attending.

There have been regional 'Strong Families, Safe Kids' discussion forums last month leading into a three day statewide 'Our Voice, Our Future' forum coming up in Hobart. This will be a unique opportunity for young people, parents, carers, community, government and service providers to come together and create new ideas about how we can work together to support children and young people in Tasmania. We will have a number of carers from around the state representing the voice of foster and kinship carers at this forum.



Our Family is Growing

Learning Incentive Allowance 2019

A key Tasmanian Government election commitment was the allocation of \$1.2 million over three years to encourage and support young people living in Out of Home Care to continue with education and learning through a one-off payment of \$2500 to both the young person and carer.

The 2019 Learning Incentive Allowance provides the option of staged carer payments to assist with educational costs for the young person throughout the year.

Under this program the young person will receive a one-off payment of \$2500 upon completion of Year 12 or equivalent in 2019 or 2020.

Ticket To Play

Ticket to Play is a Tasmanian Government initiative designed to reduce the cost of participating in club sporting activities for Tasmanian children. Ticket to Play will be launched on 8 February.

ABOUT TICKET TO PLAY

Tasmanian children aged 5 to 17 who are listed on a Centrelink Health Care or Pensioner Concession Card, or who are in Out of Home Care, are eligible for a voucher of up to \$100 in value to be used towards the cost of club membership.

The key objective of Ticket to Play is to increase the number of young Tasmanians playing sport and supporting the Tasmanian Government's objective of Tasmania being the healthiest population by 2025.

WHO IS ELIGIBLE FOR A VOUCHER?

Applicants must be:

- living in Tasmania;
- aged between 5 and 17 years old at the time of application; and
- be listed on a valid Centrelink Health Care or Pensioner Concession Card (either their own or their parent, guardian or carer's) or be in Out of Home Care.

WHAT CAN I USE A VOUCHER FOR?

The voucher can be used at approved activity providers who meet certain eligibility criteria. You can search for approved activity providers on the Ticket to Play website

The voucher is available for use toward the cost of membership fees. Other items such as uniforms, equipment, boots etc. are not eligible.

HOW DO I APPLY FOR A VOUCHER?

You can apply for a voucher through the Ticket to Play website: www.communities.tas.gov.au/ticket-to-play from 8 February 2019.

The system will assess your child's eligibility and, if approved will automatically send you a unique code via email that you will need to provide to the activity provider at the time of registration.

WHEN WILL THE PROGRAM FINISH?

Vouchers are available from 8 February 2019 and must be redeemed by 31 October 2019.
