It has been a busy few months since I have started in the job. I have attempted to engage all stakeholders over this time, to gauge the sector and guide FKAT moving forward.

A quick list of events:

I have been involved in ongoing discussion with Child Safety and NGOs around improving the process surrounding care concerns. We had the Handbook launch at FKAT Centre on 1st September that was very well attended and had good media coverage. I have had a number of productive conversations with kinship carer representatives about providing greater support for kinship carers. Jane and Angie from CYS and myself conducted training around the state on 'Children Entering Care' and 'Your People Transition Out of Care'. I have had conversations with the Children's Commissioner, the new Children's Advocate (Sonya Pringle-Jones), as well as representatives from Child Safety and the NGOs around needs fo foster and kinship carers. I have been working on a Departmental committee looking at improving the retention and recruitment of foster and kinship carers in the State, as well as a collaborative project looking at developing a better working relationship between carers and Departmental Out of Home Care support service. I attended the National Foster and Kinship Care Conference, and was impressed by the work Foster Care Queensland are doing in collaboration with Queensland Child Safety.

We had an open day at the FKAT Centre for Foster Care Week and Sonya-Pringle-Jones n the Children's Commissioner attended on the day.

FOSTER AND KINSHIP CARE ADVOCACY AND SUPPORT TEAM

The Foster and Kinship Carer's Association of Tasmania established FAST in 2005 with the aim of providing greater levels of support and advocacy for Foster and Kinship Carers. This move was in response to both state and national surveys that indicated that carers would prefer to be supported by foster care peak bodies and other Foster Carers.

FAST is a team of trained Foster Carers that have volunteered to provide support, advice and advocate on the behalf of other Foster or Kinship Carer either in a group or individual basis. Some of the issues covered by FAST include the Child and Young Persons Act, funding for those in care, complaints in care, insurance, planning for leaving and after care guidelines.

working with children check

Some carers have attempted to re-register when their WWCC is due to expire in a month or so and have found the electronic system will not process their request. Eloise from the WWCC department reports that this may have occurred for two reasons.

Firstly, it is not possible to re-register until 30 days prior to the expiry date. Secondly, there is a glitch in the system in response to the change of name from Department of Health and Human Services to Department of Communities. Eloise indicates that if carers find themselves unable to re-register even though their expiry date is less than 30 days, it is likely to be a result of this "glitch". She advised that only staff within the WWCC department are able to address this and asks that carers contact her department on the following number 61654758.
