At the first FACT Board meeting this week, the Board decided on several key priorities which include

- Facilitating sector participation and representing the sector into the Commission on Enquiry into Child Sexual Abuse and enhancing our approach to safe-guarding;
- Child Safety and other Service System Reforms, including contributing to consultations as they arise (see page XX for details on current consultation processes).
- Responding to the needs of under 16 group of young people who are or are at risk of homelessness.
- Participating in the national agenda through the national Child Wellbeing Association and continuing the advocacy push for Kinship Carers.

On behalf of the Board, I welcome your feedback and extend an invitation to all members to get involved and have your voice heard.

2020 CHAIR'S REPORT TO AGM

This year has been a busy year for all FACT Board Members as we try to meet the needs of our members and stake-holders without benefit of having an Executive Officer as we have had in previous two years. FACT again submitted a budget submission with the support of our members and national peaks but unfortunately were not successful in achieving funding this year.

Despite our limited human resources we have had a positive impact across the sector and represented Tasmania at a range of state and national forums.

FACT Board members were active participants in the Our Voice Our Future Project and followed this project through to its conclusion in May 2020. FACT was sorry to see that this project did not attain the outcomes that had been anticipated at its commencement but acknowledge that it did reinvigorate relationships and connections across the sector. There is still a great deal more work to undertake in this space.

FACT hosted a workshop with the eminent Dr Lucy Peake focusing on Informal Kinship Carer which was well received by members and guests alike. FACT was represented at a range of forums and events including a workshop hosted by the Department of Social Services focussed on establishing a centre of excellence for child sexual abuse and participated in the Youth Taskforce.

FACT prepared a submission in response to the Department of Communities Consultation for developing a program to prevent harmful sexual behaviours for children and young people in Tasmania.

The FACT Board has met with the Secretary and Deputy Secretary for Children, Department of Communities, to discuss the ongoing reform agenda and to offer the assistance of FACT members in achieving that agenda. We have also met with the Commissioner for Children to also progress the priorities of our sector. As an example FACT has persisted with our efforts to negotiate a sector wide protocol to facilitate the smooth transition of foster carers between agencies when issues cannot be resolved or where a particular services is a better match for a foster carer's needs. This agreement is nearing agreement and FACT hopes that it will be implemented in 20/21.

In the second half of 2019/20 FACT was committed to participating various forums relating to the COVID-19 Pandemic and working with TASCOSS to ensure the views of our sector were represented though the Communities Services Industry Roundtable. A significant commitment was our participation in the Premier's Council for Social and Economic Recovery which met on a very regular basis for a six month period of this year.

FACT is the state of Tasmania's peak body representative on the National Child and Family Welfare Association and we have attended all meetings of this network this year.

The FACT Board also holds a position on the Advisory Board to the Australian Child Maltreatment Study which is the first national study of the prevalence and health impacts of all five forms of child maltreatment in Australia (physical abuse, sexual abuse, emotional abuse, neglect, and exposure to domestic violence). A presentation on this project is scheduled for the upcoming annual general meeting.

FACT continued to prepare newsletters and disseminate information as broadly as possible across the sector and we aim to continue this role, acknowledging that this has been impacted by the lack of a staff member to take on this function.

The FACT Board made the decision to suspend the collection of membership fees in the 19/20 financial year and will review this decision at the upcoming AGM.

FACT strives to continue to be a voice for children and families via our member organisations in 2020/21. We look forward to increased communication, consultation and shared decision making with the Governments at all levels in 2021.

The Government has published draft *Child Safe Organisations Legislation* for consultation and comment. This legislation will apply to all organisations who have a funding agreement with the State Government so it is important that you read it and have your say.
